Thank you for your interest in Little Learners Preschool. I look forward to working together to make preschool a wonderful experience for you and your child. Below you will find some important information about the preschool including our approach to teaching, school schedule, and tuition rates. If you feel that we are the right fit for your child, please fill out the attached registration form along with the \$50, non-refundable registration fee.

Little Learners is a private, home-based preschool that is licensed both in the state of Virginia and Loudoun County. We provide a safe environment that supports children's social, emotional and academic development. Our approach involves a variety of hands-on activities, interactive lessons, and cooperative play centers that teach letters, numbers, shapes and colors, problem solving skills, social skills, gross and fine motor skills, and beginning reading, writing and math concepts. Our teachers nurture individualism and self-esteem by encouraging each child to progress at his/her own rate. Our goal is to ensure that the transition to Kindergarten is as seamless as possible.

Our school year begins the Tuesday following Labor Day and ends the Friday before Memorial Day. We follow the Loudoun County Public School calendar for holidays, snow days, and teacher work days. Students must be at least three years old and potty trained to attend. Our school hours are 9:00AM to 12:30PM, Monday through Friday. We offer a two day (Tues, Thurs) class for three and younger four year olds and a three day (Mon, Wed, Fri) class for four and five year olds. Tuition rates for the 2019-2020 school year are as follows:

Two Day, 3 Year Old Class	9:00AM – 12:30PM	Tues/Thurs	\$240/month
Three Day, 4/5 Year Old Class	9:00AM – 12:30PM	Mon/Wed/Fri	\$335/month

\*Please note that there is no option for a five day class.

Tuition for September is due by August 1<sup>st</sup>, along with signed parent handbook and all required forms. If these are not received by August 1<sup>st</sup>, you will forfeit your child's spot in the class. Tuition for the months of October through May will be due on the first of the month PRIOR (October's tuition is due September 1<sup>st</sup>, May's tuition is due April 1<sup>st</sup>) and will incur a \$15 late fee if not turned in by the 6<sup>th</sup>. There are no supply fees.

If you have any questions regarding Little Learners Preschool, please don't hesitate to contact me. Once you register, you will be given all the necessary forms that are required for enrollment. You will also receive a parent handbook that gives specific details about our school day and outlines all of our school policies.
